Cub Scout Overnight Event Tenting Waiver

To mitigate the spread of COVID-19, we recommend all Cub Scouts to tent 2-3 per tent, Scouts 2 per tent and Adults to tent alone or with spouse during the Overnight Camperall Event.

However, this form gives permission for two or three Cub Scouts to tent together if the parents/guardians of each camper consent.

In accordance with Youth Protection Requirements of the Boy Scouts of America, Cub Scouts of more than two years difference in age are not allowed to camp together. Even with signing this form, this requirement must be kept. This form must be signed prior to the start of Camperall and will be reviewed upon check-in.
